Subject: Regarding false publication, Violations of Competition Rules & Defaming of individual or organizations.

This is in regard with the information provided by our client, we are serving you this legal notice as under:

- 1. That, our client Mr. Santosh Shukla (President, World Book of Records) Address: 18/3, Pardeshipura, Near Electronic Complex, Indore 452 003 (Madhya Pradesh) India is a reputed and well-known personality of Indore and across the country, having an initiation of World Book of Records.
- 2. That, the World Book of Records is a organization wherein our client deals with a programme with a motive to certify and encourage local and international talents, who does not get an opportunity of getting their talents acclaimed and certified. Under World Book of Records our client is continuously associated with many individuals, social, economical, financial and political organizations through whom our client gets to know the unacclaimed talents, may it be individuals or an organization.
- 3. That, you as an organization are giving the records for felicitating and acclaiming the work or acts done by an individual or an organization as per your details presented on website you have been working since last many years for the same. Our client got an information this morning that you have published an information in form of an article on your official website under url http://indiabookofrecords.in/fakerecordbooks/ which was continiously circulated by you on various media platforms, showing that you as a record giving organization are the only one in India and neighbouring countries who is only working on the legal principle and guidelines laid down by the Government.
- 4. That, in this regard under this article, you have given an *INTERNATIONAL PROTOCOL for RECORDS* (*IPRs*) under which their are five headings for identifying fake record books. As per the legal protocol and the information provided across the globe, their is no such International Protocol for Records which you have willfully placed on your official website which is truly forged. Then on, in the next paragraph of your article on your official website you have mentioned that in India their is no control by the Government on the organizations presenting the National and International records for acclaiming individuals and organizations, on the contrary the Government has clearly given the rules and regulations under the registration for these kind of record books by RNI (Registered News Paper of India) Number and ISBN (International Standard Book Number), which again shows that due to lack of awareness and knowledge you are providing forged and misleading information on your official website.
- 5. That, in furtherance, in the next column of your article on your official website you have mention a partial list of Fake Record Holder Books under which the second last name contains "World Book of Records". By keeping the World Book of Records under your fake record holder books list you have clearly violated the law of the land, wherein without any certified evidence you can not publish any name under your fake list. Secondly the World Book of Records has a legal sanctity and identification within the legal system of India. The World Book of Records is registered as World Book of Records Foundation, India holding CIN U74996MP2017NPL042166 dated 10th January 2017 under Indian legal system and as World Book of Records Limited, London with the Company Number 10670635 dated 15th March 2017, World Book of

Records Inc, The State of Washington of United States of America with UBI Number - 604 249 116 dated 30 March 2018 and World Book of Records Pty Limited, New South Wales of Australia with Australian Company Number - 627 286 711 dated 3rd July 2018. World Book of Records is also registered under RNI Number MPHIN/2018/64649 dated 9th November 2015 as Alma Today which is an official Publication of World Book of Records (also mentioned on website of World Book of Records) and ISBN Number ISBN 978-81-924811-0-4 under the name of Alma Publication. This whole process done by the organization of our client clearly shows that our client is working under proper legal compliance and fulfilling every legal aspect.

- 6. That, this particular act done by you shows that your attitude towards our client is not competitive and as per the corporate behaviour, on the contrary you have violated every aspect of the provisions wherein you are targeting our client on false & forged allegations along with infringing the privacy of business of our client by publishing our client's name in your official website's Fake Publication. This act of yours against our client comes under the criminal and civil violation within the law of the land.
- 7. That, in furtherance, due to your objection on so called fake records book, our client also demands you to send the documents pertaining the documents of registration of Asia Book of Records, under which you are affiliated as per the details given in your official website. As per the details given by you that, "follows the International Protocol of Records as per the consensus arrived at in the meeting of the Chief Editors of National Record Books, Ho Chi Minh City, Vietnam", is not available as record or dated note anywhere on internet except on your official website. We also demand you to provide us with the official details of the event along with the minutes of meeting of the board members, who organized this event. If you are unable to suffice our client with the concern satisfactory documents, our client shall move to the appropriate legal authority for a proper action against your illegal and forged act.

Therefore, in this regard with the above mentioned facts, your particular act of publication has defamed our client and his organization nationally and internationally. Also this particular act is a severe violation of personal space and privacy along with violation of Competition Rules under Competition Act of India against our client due to which our client is prompt to legal action against you. Also, we demand you to pay the damages of Rs. 1,00,00,000 (One Crore only) for defaming our client and his organization along with removal of our client's name from your false article and publishing an official apology to our client with in seven (7) days from receiving of this notice otherwise our client has all the right to take appropriate legal action against you. Also you are deemed to pay the expenses of all the legal actions taken against you along with Rs. 30,000/- as fees for this notice.
